

## Firearms Instructor School – Phase I

**CLASS TIMES:** APPLICATION PHASE ONLY

**C E HOURS:** 16 (If attending Phase I training as a part of the instructor school)

**CLASS LIMIT:** 25

**PREREQUISITE:** To become a **CLEET** certified firearms instructor, the Firearms Instructor Candidate (FIC) must successfully complete, in succession, each of the six phases of training, which include both academics and practical firearms training. Candidate's successfully completing the Phase I application portion of the Firearms Instructor Development Program are eligible to advance to Phase II. Phase 3 must be completed within one year of phase 2. Phase 6 must be within one year of completing phase 5 unless a waver is granted.

### **EQUIPMENT:**

**Revolver:** A factory manufactured (catalog item) revolver capable of chambering and firing .38 Special ammunition.

#### **Allowed:**

1. Barrel length up to 4 inches.
2. The front sight being a ramp or post as sold by the manufacturer of the firearm.
3. Replacement of service type sights with other service type sights, luminescent service sights, or fiber optic service sights, provided such sights do not require alteration of the firearm for installation.
4. Chamfered cylinders.

#### **Prohibited:**

1. Weighted grips or grip panels.
2. Adjustable front sight.
3. Trigger shoes.
4. External trigger stops.
5. Trigger modification as to length, width, or grooves.
6. Thumb rest.
7. Grips/Stocks that when measured from side to-side at the base are greater than 1 ¾ inches in thickness (1.75").

**Semi-Automatic Pistol:** Factory manufactured (catalog item), center-fire semi-automatic pistol capable of chambering and firing .35 caliber or larger ammunition. All double action semi-automatic pistols must fire the first shot of every stage double action.

Trigger pull not less than 3.5 pounds single or double action.

**Allowed:**

1. Maximum barrel length of 5.5 inches.
2. Any accessories, parts, and components which are manufactured to duplicate, in materials and dimensions, the original as offered by the manufacturer.
3. Replacement of service type sights with other service type sights, luminescent service sights, or fiber optic service sights, provided such sights do not require alteration of the firearm for installation.
4. Maximum sight radius of 7.5 inches.
5. Finger groove and slip-on grips.
6. Magazine bumper pad.
7. Extended magazine well funnel.

**Prohibited:**

1. Adjustable front sight.
2. Thumb rest.
3. Grips/stocks that are flared at the base.
4. Full-length Bo-mar type ribs on the slide.
5. Weighted grips or grip panels.
6. Trigger shoes.
7. External trigger stops.
8. Smith & Wesson Model PPC9 Pistols.
9. Glock 17L
10. Pistols manufactured for competition (race guns)

**Holster:** Each FIC must use a holster designed specifically for the make and model of firearm employed to include trigger guard (holster covers the trigger) and a retention.

**Magazines/Speed-Loaders:**

1. Semi-Automatic: Four (4) Magazines, minimum
2. Speed-Loaders: Four (4) Minimum

**Note:** FIC's may bring as many loading devices as they wish. To enhance accountability, please mark magazines/speed-loaders with an electric scribe, a silver or black Sharpie or some other means - to insure positive identification. Magazines will be charged with a maximum of six (6) rounds.

Magazine/ Speed-Loader Pouches:

1. Minimum of one double magazine/speed-loader pouch, or
2. Two single magazine/speed-loader pouches; flaps or open top.
3. Must use department approved equipment.
4. Flaps will be secured prior to any course of fire (if equipped).

**Note:** Candidate's will furnish their own ammunition but only new, or factory spec. reload may be utilized. Candidates will need a minimum of 1,000 rounds of ammunition if attending Phase I as part of the Instructor School.

### **COURSE SYLLABUS:**

Phase I of the **CLEET** Basic Firearms Instructor School is the Application Phase. The FIC must.

1. Be certified as a full-time, salaried peace officer as set forth in Title 70, Section 3311 of the Oklahoma State Statutes.
2. Be currently employed by a municipal, county, state or tribal law enforcement agency.
3. Have two years of law enforcement experience, after **CLEET** certification, prior to beginning firearms instructor training.
4. Have successfully completed a **CLEET** approved Basic Instructor Development School prior to applying for admission to the Basic Firearms Instructor School.
5. FICs opting to participate in Phase I within their own jurisdiction are encouraged to do so. They must provide written documentation of shooting proficiency as specified by the Council on Law Enforcement Education and Training.
  - a. Fire under time (and in the presence of a **CLEET** approved firearms instructor), a minimum score of 480 points (out of possible 600) on PPC course Match V. (Attached)
  - b. Submit, to **CLEET**, a letter from the applicant's agency administrator (co-signed by the witnessing **CLEET** approved firearms instructor) attesting to the applicant's score.
6. The FIC may attend Phase I training and testing as part of the Firearms Instructor School and receive 16 hours of Continuing Education credit, if offered.
7. FIC's must shoot 480 points out of a possible 600 in order to advance to Phase II of the Firearms Instructor Development Program.

## **Firearms Instructor School – Phase II**

**C E HOURS: 24**

**CLASS LIMIT: 25**

**CLASS TIMES:** 0800 until 1700

**PREREQUISITE:** Successful completion of Phase I

**EQUIPMENT:** Same as Phase I

**Note:** Candidate's will furnish their own ammunition but only new, or factory spec. reload may be utilized. Students will need a minimum of 1,000 rounds of ammunition.

**COURSE SYLLABUS:**

Phase II of the **CLEET** Basic Firearms Instructor School is the Firearms Instructor Qualification Phase. The FIC must fire under time, a minimum score of 540-points (out of 600 possible) on Match V of the PPC course, which is approved by the Council on Law Enforcement Education and Training,

### **Firearms Instructor School – Phases III – VI**

**C E HOURS: SEE BELOW**

**CLASS LIMIT: 25**

**CLASS TIMES:** 0700 until 1800 and required "night fire" sessions

**PREREQUISITE:** Completion of Basic Firearms School – Phase I and Phase II

**EQUIPMENT:** Access to a computer (laptop is preferred) Jump drive. Duty handgun and revolver (revolver can be provided). 12-gauge pump action police shotgun: Mossberg 500 series or Remington 870 with sling and Side Saddle (required).

**Note:** A minimum of 1,500 rounds of handgun ammunition. 250 rounds of birdshot, 100 rounds of slug and 100 rounds of 00-buckshot (9 pellet) will be necessary for the shotgun. 200 rounds of .38.

**COURSE SYLLABUS:**

**Phase III** (30 hours) of the **CLEET** Basic Firearms Instructor School is the Shotgun Proficiency Phase. The FIC must:

- Achieve a score of 100% on a shotgun nomenclature and function test.
  - Achieve a score of 100% on a shotgun 5-point safety check.
  - Achieve a score of 100% on Select-A-Slug test
  - Demonstrate the ability to call courses of fire
  - Show the ability to coach shooters and detect problems
- 
- Fire, under time, a minimum score of 90 (100 possible) on 2 CLEET Shotgun Slug Qualification Course. And fire under time, a minimum score of 82 (90 possible) on 2 CLEET Shotgun 00 Buckshot Qualification Course. A maximum of 7 attempts will be given.

- Shoot the Dossier Drill in 3.5 seconds or less. (Birdshot and 00- Buckshot).
- 100% on shotgun handling skills test

**Phase IV** (30 hours) of the **CLEET** Basic Firearms Instructor School is the Academic and Procedures Proficiency Phase. The FIC must:

- Score 100% on a firearms safety test
- Achieve a score of 90% on a general knowledge test
- Demonstrate, to the satisfaction of the Firearms Instructor, the ability to coach other students, operate the tower, and perform other range duties
- Achieve 100% on handgun handling skills test
- Develop lesson plans for classroom and range presentations
- Prepare all required documents to obtain a course catalog number
- Complete the form to have a class posted to CLEET's website
- Develop courses of fire for range presentations
- Enter an officer's yearly qualification to CLEET
- Interview process

**Phase V** (30 hours) of the **CLEET** Basic Firearms Instructor School is the Handgun Instructor Phase. The FIC must:

- Demonstrate the ability to handle the semi-automatic pistol, to include proper clearance of malfunctions
- Demonstrate the ability to handle the revolver, to include Load, un-load, re-load, and proper clearance of malfunctions
- Achieve a minimum score of 100% on the CLEET Handgun Qualification Course 2 times.
- Achieve a minimum score of 90% on Smith backup course
- Achieve a score of 90% on a handgun nomenclature and function test.
- Achieve a 72% on the CLEET Handgun Qualification Course with a revolver.
- Demonstrate the ability to call courses of fire
- Show the ability to coach shooters and detect problems

The FIC's duty weapon and revolver will be utilized throughout this phase of training.

**Phase VI** (72 hours) of the **CLEET** Basic Firearms Instructor School is the Apprenticeship Phase. The FIC must serve an apprenticeship for not less than one complete **CLEET** Basic Law Enforcement Academy Firearms Course.

## **Police Pistol Combat (PPC) Match 5**

7 yards; 12 shots double action standing without support. Time limit 20 seconds including time to reload.

25 yards; 6 shots low kneeling without using the barricade; 6 shots standing left side, left hand with support from behind barricade, 6 shots standing right side right hand with support from behind barricade, all fired double action. Time limit 90 seconds, including time to reload.

50 yards; 6 shots sitting; 6 shots prone; 6 shots standing left side, left hand with support from behind barricade; 6 shots standing right side, right hand with support from behind barricade, all fired double action. Time limit 2 minutes and 45 seconds including time to reload.

25 yards; 6 shots double action standing without support. Time limit 12 seconds.
